### Benefit

The iPad loaned to the student is covered against accidental damage. Coverage is 24 hours a day.

The following are **NOT** Covered by Technology Protection Fund:

- Negligence, abuse or intentional damage
- The protective cover, charger, and power cord
- Lost or stolen iPad *It is the responsibility of the Parent/Guardian to file a police report.*
- iPad is removed from provided case

### Effective and Expiration

Coverage is effective from the date of this required form through the date at which the iPad is returned to the school in good working order.

### iPad Protection Fees

- The *iPad Protection* fee is \$55.00 for one (1) pupil; \$45 each for two (2) pupils; \$35 each for three (3) or more pupils.
- **iPad replacement is \$455.00**

It is agreed and understood that:

- The pupil can take iPad home from school following payment of the *iPad Protection* fee
- Technology Protection coverage is offered to all students
- Participation and payment to the Technology Protection Fund is voluntary
- If no Technology Protection Fund payment is made the iPad stays in school
- A separate application and payment is required for each iPad covered
- The Technology Protection Fund payment is non-transferable
- The cost of a Lost or Stolen iPad is the responsibility of the Parent / Guardian
- There is no partial payment option
- Payment is non-refundable
